## **TERMS AND CONDITIONS**

1. The name of the project shall be DHA Bahawalpur.
2. The Plots offered to the buyers in the project shall be on ownership basis & allotment subject to balloting and allotment policy.
3. Quarterly installments shall be payable by the 5<sup>th</sup> of each month through demand draft / pay order. Prompt payment of installments on the due dates as per payments schedule is the essence of this contract.
4. The applicant shall make the payment of installments within the period specified. If the applicant fails to pay the payment / dues within the period as mentioned in the final notice, the application will be liable to cancellation as per term (5) of this form.
5. In case of failure on the part of the applicant to make payments within the prescribed period as per schedule or after being served the FINAL NOTICE, the application / allotment will stand cancelled. The amount deposited by the applicant shall be refunded after deduction of 20% of total deposited amount and membership fee.
6. The application in respect of the allotted plot shall be transferred only after payment of all the dues and other charges against the said plot. The application deems to be cancelled in case of default of the down payment or processing fee and the applicant shall not be entitled for any claim / allotment.
